Visit with a local congregation this morning before discovering the distinctly Caribbean spirit of Santiago de Cuba, evident in every aspect of the city's Afro-Cuban cultural life. Cuba's second largest city is home to the popular festivals of Carnaval and the Fiesta del Fuego, as well as to many of the country's most famed musicians and artists. Its diverse architecture ranges from the Spanish coastal fortress of Castillo del Morro to the red-domed towers of the Basílica de Nuestra Señora de la Caridad del Cobre, Cuba's most sacred pilgrimage site within Soberania National Park.

CULTURAL EXCURSION

Cienfuegos

The coastal city of Cienfuegos is known to Cubans as "the Pearl of the South." Near the entrance to the bay stands the imposing fortress of Castillo de Jagua, built in 1745 to protect the city against pirate attacks.

P2P Certificates, Cuban Visas & Medical Insurance Disclaimer:

Guests will be required to attend lectures during the cruise to meet the people to people requirement for this cruise. They will receive the required P2P certificate at the end of the cruise and need to keep it for 5 years in compliance with current OFAC rules.

Cuban Visas are also required for this program. Guests may purchase these from the airline or in advance from a Cuba Visa Service's website. Select "Educational - People to People" as the OFAC Category for the Visa.

Mandatory Cuba health insurance is required for all guests. If it is not included in your airline ticket, you may purchase Celestyal Cruise Line's plan for \$48 per person.
