Highlights of Paul's Missionary Journeys

Sept. 28 & 29 - Depart the USA - Arrive in Rome

Your pilgrimage begins as you depart the USA and arrive in Rome. Time permitting, take a panoramic tour of the Eternal City before embarking on the luxurious Celebrity Reflection.

Sept. 30 - Sicily, Italy

Explore Messina, a city rich in history, and the connecting point of the "Italian Boot." In neighboring Taormina, climb to the mountaintop Greek Theater with its spectacular views of the Mediterranean and Mt. Etna. Enjoy a gelato while shopping or simply wander the streets with the occasional breathtaking view over the cliffs to the seaside below.

Oct. 1 - Valletta, Malta

Paul was shipwrecked on Malta around 60 AD (Acts 28). After the Knights of St. John successfully defended Malta against a massive Ottoman siege in 1565, they built the fortified town of Valletta. Explore the town and visit the Barrakka Gardens that were built on a bastion of the city and offer a breathtaking view of the Grand Harbor.

Oct. 2 - At Sea

Oct. 3 - Rhodes, Greece

Paul visited Rhodes briefly on his way to Jerusalem at the end of his third missionary journey. Over 1,200 years later when Jerusalem fell during the Crusades, the Knights of St. John fled to the island of Rhodes, where they ruled for two centuries. Suleiman the Magnificent finally captured the island, but lost 50,000 men in the campaign. The castles and old town built by the knights are still impressive today.

Oct. 4 - Mykonos, Greece (on own)

Have a delightful day exploring the exceptional beauty and culture of the Greek island of Mykonos with its lovely bays and beaches, distinctive whitewashed structures, and cobblestone streets.

Oct. 5 - Santorini, Greece (on own)

Visit Santorini, one of the most beautiful of the Greek islands. Its picturesque whitewashed villages with brilliant blue domes dot the cliffs above the Aegean Sea. The island itself perches on the edges of a volcano whose eruption 3,500 years ago is thought to have led to the collapse of the Minoan civilization.

Oct. 6 - Athens & Corinth, Greece

The architectural splendors of the ancient city of Athens are as magical as ever. View the world-renowned Acropolis, the Propylaea, and the Parthenon. Time permitting, view Mars Hill where Paul debated with the intellectual community of his day. Walk among the ruins of the Agora, the ancient market place and center of Athenian public life. You will view the Olympic Stadium, home of the Olympics. Travel to Corinth (Acts 18), a city that inspired St. Paul's most familiar letter. You will visit the Archaeological Museum, the Market Place, and Temples. Walk among the ruins and stand on the Bema where Paul stood. Read Paul's letter to the Corinthians and visualize his address to the Gentiles as he began the task of building Corinth's church.


Oct. 7 - At Sea

Oct. 8 - Naples & Pompeii, Italy

Arrive in Naples, a dazzling city perched on a beautiful rock coast. Paul landed in the bay of Naples on his way to Rome. You can journey inland to ancient Pompeii, dating almost to the time of Paul, where you can see the spectacular ruins that were covered by ash from the eruption of Mount Vesuvius in A.D. 79.


Oct. 9 - Rome, Italy to USA or continue on the exciting Rome Post-Tour

Price is per person based on double occupancy. When available, single rooms/cabins are often smaller than doubles. While EOT will try to match roommates, EOT cannot guarantee one will be available. Roommates may be assigned as late as 35 days prior to departure and, if one is not available or if you request a single, the following single room/cabin charges apply: 175% of the cabin category price selected for basic itinerary. \$198 for the Rome Pre or Post Tour. Single staterooms are extremely limited and subject to confirmation.

SAVINGS:

Early registration discounts or other promotions are deducted from the balance of your bill. Hosts/Co-hosts are not eligible.

PAYMENT:

All prices reflect a 4% cash discount for full payment via check. A full deposit of \$500 per person is required. An additional deposit of \$600 is due 4/01/17. Travel Protection Premiums must be paid by the final payment date for coverage to be in effect. Final payment for trip is due 5/31/17. Thereafter, a late payment fee of \$100 will be assessed.

REGISTRATIONS RECEIVED after May 31, 2017:

We welcome registrations after 5/31/17. All Registrations received after this date may incur an additional fee based on cruise availability as well as the following fees. Registrations received between 5/31/17-6/30/17 will incur a \$100 per person air fee. Registrations received between 7/01/17 - 7/15/17 will incur a \$200 per person air fee. Registrations received after 7/16/17 will incur an additional fee based on air availability. Additional fees will be advised upon registration.

CANCELLATION FEES:

100% of Cancellation Fees are covered by the optional Travel Protection Program provided premium has been paid and reason for cancellation is insurable.
