ITINERARY



February 23 & 24 – USA to the Holy Land

Your pilgrimage begins as you depart the USA on an overnight flight. You will be welcomed at the Tel Aviv airport by our representative and transferred to your hotel to enjoy dinner before retiring for the night.

February 25 – The Galilee

Worship as you sail across the Sea of Galilee. Visit Capernaum, the center of Jesus' ministry in the Galilee, and visit the synagogue built on the site where Jesus taught (Matthew 4:13, 23). On the Mount of Beatitudes, contemplate the "Sermon on the Mount" (Matthew 5-7). Explore the Church of the Loaves and Fish at Tabgha, the traditional site of the feeding of the 5,000 (Luke 9:10-17). See the Chapel of the Primacy, where Peter professed his devotion three times to the risen Christ (John 21). In Magdala, once home to Mary Magdalene, visit a recently discovered first-century synagogue.

February 26 – Cana, Nazareth, Tel Megiddo & Caesarea

Visit the Franciscan Wedding Chapel in Cana, the site of Jesus' first miracle, before continuing on to Nazareth, Jesus' boyhood home (Matthew 2:23). Look out over Tel Megiddo (Armageddon) to view one of the most important archaeological sites in Israel. Today's last stop is Caesarea, a center of the early Christians, where an angel visited Cornelius, the first Gentile believer (Acts 10), and where Paul was imprisoned for two years before appealing to Caesar.

February 27 – Beit Shean, Jericho, & Qumran

Start the day in Beit Shean, a city continuously inhabited for over 5,000 years. The uncovered ruins date back to the Greek/Roman city that was part of the Decapolis of Jesus' day. See colonnaded streets with marble sidewalks, Roman public baths, and a theater. As you stop in Jericho to view the ruins of the city conquered by Joshua (Joshua 6:1, 2, 20), in the distance, you can see the traditional site of the Temptation of Jesus (Matthew 4:1-11). Continue to Qumran, where the Dead Sea Scrolls were discovered in 1947. Finish your day at the baptismal site of Qasr el Yehud, where tradition says Jesus was baptized by John the Baptist.

February 28 – Bethlehem & Jerusalem

In Bethlehem, visit the cave revered as Jesus' birthplace and see the Church of the Nativity constructed over the site (Matthew 1:18-25). Gaze out over Shepherds' Field before returning to Jerusalem. Explore the poignant exhibits of Yad Vashem, Israel's Holocaust Memorial.

March 1 – Jerusalem & the City of David

Begin your day with a group picture taken from the Mount of Olives, where Jesus ascended into heaven (Acts 1:9-12). Walk the Palm Sunday Road and pray in the Garden of Gethsemane and envision the scenes of the night before Jesus' crucifixion (Matthew 26:36 - 44). Continue to Mount Zion to visit the House of the High Priest Caiaphas, where Jesus was questioned the night of His betrayal (Matthew 26:57). Meditate on the events of the Last Supper as you visit the traditional location of the Upper Room (Mark 14:12-26). After lunch, wander through the excavations of the City of David. Explore Hezekiah's Tunnel, an amazing engineering feat that was dug from both ends and met in the middle (Those who are claustrophobic may want to meet the group at the other end of the tunnel)! Visit the Pool of Siloam, recently uncovered at the foot of the city.

March 2 – Masada & the Dead Sea

Ascend by cable car to Masada, Herod's legendary mountaintop fortress, which became the last desperate stronghold of the Jewish Zealots against the Romans. You can still look down on the remains of the Roman camps and the siege ramp below. End your day with a dip in the salt and mineral-laden waters of the Dead Sea.

March 3 – Jerusalem & the Old City

Explore ancient Jerusalem at the Teaching Steps and the Western Wall. View the Pool of Bethesda, where Jesus performed the Sabbath miracle (John 5:1-18). Sing a hymn in the Church of St. Anne and experience its rich acoustics. Visit Herod's Antonia Fortress, where Jesus appeared before Pontius Pilate (Luke 23:1), and follow in Christ's steps on the Via Dolorosa ("the Way of the Cross"). At the Church of the Holy Sepulchre, take time to reflect on His sacrificial love. Visit the Garden Tomb for a time of reflection and communion.

March 4 – Return to the USA.

CANCELLATION FEES:

100% of Cancellation Fees are covered by the optional Travel Protection Program provided premium has been paid and reason for cancellation is coverable. Those who do not take travel protection should be aware of the following per-person cancellation penalties: From day of registration to 105 days prior to departure, you will be charged the \$100 non-refundable cancellation fee plus any airline fees. Additionally, thereafter, you will be charged any airline penalties and a single room supplement if your cancellation forces your roommate into a single plus the following per-person charges: 104-60 days = \$400; 59-45 days = \$600; 44-31 days = 40% of total cost; 30 days to day of departure = 100% of total cost. Submit cancellation in writing. On or after day of departure, there will be no refund for any services not used.

STATEMENTS OF RESPONSIBILITY

EOX does not accept responsibility for losses or additional expenses due to delay or changes in air schedules, hotel overbookings, other hotel related problems or causes, and/or travel supplier cancellations or postponements. Because many of the sites are not accessible to the physically challenged and space limitations on tour buses, wheelchairs and scooters cannot be accommodated. Those needing oxygen or other ambulatory assistance will find the tour extremely limiting in their experiences. Persons using C-pap machines requiring distilled water will need to inform us ahead of time, so we can work with local operators to prepare as it is not always available. EOX reserves the right to refuse or revoke travel to anyone who is, in the sole judgment of EOX, incapable of group travel without causing undue demands upon the staff or other tour participants. Accessible rooms/cabins are limited and subject to confirmation after receiving the passenger's written request.
