












# ITINERARY

August 1 – Depart the USA\* Depart the USA on your flight to Tanzania.\*

# August 2 – Arusha

Arrive at Kilimanjaro International Airport. Meet your driver/guide before transferring to the African View Lodge for dinner and your overnight stay.

# August 3 – Tarangire National Park

Enjoy breakfast at the lodge before driving to Tarangire National Park for a game-viewing drive. Enjoy a picnic lunch, then continue for an afternoon game-viewing drive. End the day in Karatu Highlands for dinner and your overnight stay at Country Lodge.

# August 4 – Ngorongoro Crater/Central Serengeti National Park

Enjoy breakfast at the lodge in the morning. Drive to Ngorongoro Crater for a half-day crater tour. Enjoy a picnic lunch, then proceed to Serengeti National Park, arriving in good time for an evening game drive. Continue to Ang'ata Serengeti Camp for dinner and overnight.

# August 5 – Central Serengeti National Park

Enjoy a full day of unlimited game viewing in the Central Serengeti. All meals and your overnight stay are at Ang'ata Serengeti Camp.

# August 6 – North Serengeti National Park

Enjoy breakfast at the camp in the morning. Drive to North Serengeti with a game-viewing drive en-route. Enjoy a picnic lunch before continuing to North Serengeti for an evening game drive. Continue to Kirurumu Serengeti North Camp for dinner and overnight.

# August 7 – North Serengeti National Park

Enjoy a full day of unlimited game viewing in the North Serengeti. All meals and your overnight stay are at Ang'ata Serengeti Camp.

# August 8 – Central Serengeti National Park

Enjoy breakfast at the camp in the morning. Drive to Central Serengeti with game drive en-route. Have a picnic lunch together before continuing to Serengeti Pure Tented Camp for dinner and overnight.

# August 9 – Karatu Highlands

Enjoy breakfast at the camp in the morning before a morning game drive in Central Serengeti National Park. Drive to Karatu via Ngorongoro before checking into Marera Valley Lodge for dinner and overnight.

# August 10 – Depart



# August 11 – Return Home


Return home with incredible memories of your time in Tanzania!\*

\*One group transfer is included to/from the airport. EOX would be happy to make flight recommendations within 10 months of the trip departure.














# ABOUT YOUR HOST... Mark Ziese

We welcome registrations after 04/08/25. Registrations received after this date may incur additional fees based on availability. Additional fees will be advised upon registration CANCELLATION FEES:

Those who do not take travel protection should be aware of the following per-person cancellation penalties: From day of registration to 105 days prior to departure, you will be charged the \$100 non-refundable cancellation fee plus any airline fees. Submit cancellation in writing. On or after day of departure, there will be no refund for any services not used.
